KAU -Acad-Decisions of 128th Academic Council-recommendations of Sub Committee to examine the issue of Check System and the conduct of one-time re-examination in UG & B.Sc.-M.Sc.(Integrated) Courses – Sanctioned - Orders issued.

ORDER

A resolution regarding the issue of check system and one time re-examination was placed in the 128th meeting of Academic Council. The Academic Council decided to constitute a Sub Committee for examining the above matters and make recommendations.

As per the recommendations of the Sub Committee the following orders were issued.

<u>UG Courses (Applicable to 2013, 2014 and 2015 Admission Batches)</u>

- Registration of 8th semester will be allowed only if the student clears all the courses of the first and second year. However, conditional registration will be allowed for students awaiting the results of the one-time-re-examination held during the 7th semester.
- For the students having backlog, one time re-examination will be conducted during the 7th semester without insisting the maximum credit limit for registration and the restrictions during RAWE.
- Registration for special re-examination can be done in the 7th semester within 7 days after publication of results of 6th semester.
- Results of this one time re-examination will be published as early as possible, but necessarily before the end of 8th semester.
- Students who have written the one time re-examination will be allowed conditional registration of 8th semester and depending upon the results, the registration will stand or get cancelled. If cancelled, due to the failure of courses in the one time exam, the student should re-register 8th semester after clearing all courses of first and second year and complete the courses of the 8th semester afresh with junior batch.

The B.Sc./M.Sc.(Integrated) Courses (Applicable to 2013 Admission Batch onwards)

- Registration of 9th semester will be allowed only if the student clears all the courses of the first three years.
- For the students having backlog, one time re-examination will be conducted during the 7th semester without insisting the maximum credit limit for registration.

- Registration for special re-examination can be done in the 7th semester within 7 days after publication of results of 6th semester.
- Results of this one time re-examination will be published as early as possible, but necessarily before the end of 8th semester.

The Orders are issued subject to ratification by Academic Council.
