ORDER

As per the recommendations of the 66th Board of Studies (Agri.) held on 16.06.2023 it was proposed to amend the existing rules concerned with actions to be taken while dealing with malpractices attempted during examination. The matter was placed before the Special Academic Council meeting held on 11.07.2023.

In consonance with the decision of the Special Academic Council the following amendments to the existing regulation are approved.

2	<p>Clause -26.4.</p> <p>The committee shall submit its findings within a specified time to the Head of the Institution whose decision on the matter shall be final.</p>	<p>The Committee shall submit its findings within 5 WORKING DAYS to the Head of the Institution whose decision on the matter shall be final.</p>
